

DESCRIPTION OF SURVEY FOR ROBERT TAYLOR & VESTA TAYLOR JOB#1778-3

Situated in the State of Ohio, County of Muskingum, Township of Union:

Being part of the Northwest Quarter, of Section 8, of Township 1, Range 5, of the US Military District, further being part of the Vesta Taylor and Larua J Berry Trustee property recorded in Official Record Volume 2225, Page 657, of said county's deed records, further being part of Muskingum County Auditor's Parcel Number 66-10-08-19-000, and more particularly described as follows;

Commencing at an iron pipe (found) at the common corner for Sections 3, 4, 7, and 8 of said Township and Range;

- TIE-1 THENCE South 88 degrees 07 minutes 35 seconds East 1760.41 feet** along the common line for Sections 3 and 8 to an iron pin (set) at the common corner for said Taylor property and for the Marion P Read property recorded in Official Record Volume 2173, Page 439, passing an iron pin (found) at 430.44 feet being the common corner for said Taylor property and for the Raymond E Dailey property recorded in Deed Book Volume 1045, Page 401, also passing an iron pipe (found disturbed) at 199.86 feet;
- TIE-2 THENCE South 06 degrees 48 minutes 50 seconds East 1126.57 feet** into said Northwest Quarter and along said Taylor and Read properties to an unmarked point in the centerline of Norwich Drive (Township Road #692), passing iron pins (set) at 908.40 feet and 1084.91 feet;
- TIE-3 THENCE North 80 degrees 36 minutes 55 seconds West 199.90 feet** along said road to an unmarked point;
- TIE-4 THENCE North 80 degrees 05 minutes 30 seconds West 149.00 feet** continuing along said road to the unmarked place of beginning for the property herein intended to be described;
- #1- THENCE North 80 degrees 05 minutes 30 seconds West 31.65 feet** continuing along said road to an unmarked point;
- #2- THENCE North 80 degrees 27 minutes 05 seconds West 198.35 feet** continuing along said road to an unmarked point;
- #3- THENCE North 09 degrees 32 minutes 55 seconds East 300.00 feet** leaving said road and through said Taylor property to an iron pin (set), passing an iron pin (set) at 40.00 feet;
- #4- THENCE South 80 degrees 27 minutes 05 seconds East 203.64 feet** continuing through said Taylor property to an iron pin (set);
- #5- THENCE South 03 degrees 36 minutes 35 seconds West 89.84 feet** continuing through said Taylor property to an iron pin (set);
- #6- THENCE South 01 degrees 00 minutes 10 seconds West 118.77 feet** continuing through said Taylor property to an iron pin (set);
- #7- THENCE South 09 degrees 54 minutes 30 seconds West 93.39 feet** continuing through said Taylor property to the place of beginning, passing an iron pin (set) at 53.39 feet, containing 1.50 acres, of which 0.21 acres are within the right of way for Norwich Drive (Township Road #692).

The bearings within this description are based on State Plane Coordinate Grid (Ohio South 1983) derived from GPS Observations. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).
