PART OF AUDITORS PARCELS
66-15-03-02-000 (1.22 acres)
66-10-08-25-000 (2.31 acres)

Situated in the Northeast Quarter of section 7, and the Northwest Quarter of Section 8, T-1, R-5, U.S.M.L., Union Township, Muskingum County, Ohio. Being part of the lands of Gerald De Palmo conveyed in deed book 1582 page 689 of the Muskingum County Deed records, and being described as follows:

Commencing at the Southeast Corner of the Northeast Quarter of Section 7; Thence, N.06°11'39"E. a distance of 585.44 feet along the East line of said quarter section to a point, and BEING THE POINT OF BEGINNING;

Thence, N.87°15'25"W. a distance of 172.82 feet through the lands of G. De Palmo (1582/689) to a set rebar;

Thence, N.02°06'33"E. a distance of 287.74 feet through said DE Palmo lands and along the lands of E. Lazar (1038/490) to a found iron pin on the Southwest corner of the lands of J. Prall (1584/200);

Thence, S.88°59'36"E. a distance of 432.13 feet along the south line of said Prall lands to a point in the center of C.R. 436 (Moose Eye Road), passing a found iron pin at 396.28 feet;

Thence, S.32°10'54"E. a distance of 111.88 feet along the center of said road to a point;

Thence, S.28°00'39"E. a distance of 89.78 feet along the center of said road to a point;

Thence, S.18°08'09"E. a distance of 80.87 feet along the center of said road to a point;

Thence, S.05°32'40"E. a distance of 56.97 feet along the center of said road to a point;

Thence, N.87°15'25"W. a distance of 402.92 feet through the lands of G. De Palmo (1582/689) to the point of beginning, passing a set rebar at 20.00 feet;

The above described parcel contains 3.53 acres, more or less, and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic U.D. caps. North is based upon an assumed meridian.
