SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM, TOWNSHIP OF UNION, AND BEING PART OF THE NORTHEAST QUARTER OF SECTION 7, AND PART OF THE NORTHWEST QUARTER OF SECTION 8, TOWNSHIP 1, RANGE 5, AND BEING PART OF THOSE LANDS INTENDED TO BE DESCRIBED IN DEED VOLUME 960, PAGE 266; BEING FURTHER BOUNDED AND DESCRIBED AS FOLLOWS:

BEGINNING AT A STONE FOUND AT THE SOUTHEAST CORNER OF THE NORTHEAST QUARTER OF SAID SECTION 7, THENCE, ALONG THE SOUTH LINE OF SAID QUARTER, NORTH 84 DEGREES - 09 MINUTES - 40 SECONDS WEST, 400.73 FEET TO AN IRON PIN FOUND AT THE SOUTHEAST CORNER OF THOSE LANDS INTENDED TO BE DESCRIBED IN DEED VOLUME 1079, PAGE 293; THENCE, NORTH 05 DEGREES - 50 MINUTES - 20 SECONDS EAST, 123.75 FEET TO AN IRON PIN FOUND; THENCE, NORTH 84 DEGREES - 09 MINUTES - 40 SECONDS WEST, 352.00 FEET TO AN IRON PIN FOUND; THENCE, NORTH 05 DEGREES - 50 MINUTES - 20 SECONDS EAST, 350.00 FEET TO AN IRON PIN SET; THENCE, SOUTH 87 DEGREES - 15 MINUTES - 45 SECONDS EAST, 1169.05 FEET TO A POINT IN THE CENTER OF COUNTY ROAD #436, PASSING AN IRON PIN SET AT 1150.61 FEET; THENCE, ALONG SAID ROAD, THE FOLLOWING THREE (3) COURSES AND DISTANCES:

- 1) SOUTH 03 DEGREES - 05 MINUTES - 30 SECONDS WEST, 55.78 FEET TO A POINT;
- 2) SOUTH 08 DEGREES - 13 MINUTES - 36 SECONDS WEST, 392.20 FEET TO A POINT;


