Situated in the State of Ohio, County of Muskingum, Township of Union,
Township 1, Range 5, part of the Southwest and Northwest Quarters of
Section 8, and bounded and described as follows:

Parcel One:

Commencing at a corner post at the Southwest corner of (offset) Southwest
corner of the Northeast Quarter of Section 8; thence South $2^{\circ} 19' 29''$
East 276.14 feet to a point, the Southeast corner of the Northwest Quarter
of Section 8; thence South $88^{\circ} 02' 45''$ West on South line of Northwest
Quarter to the right-of-way line of B. & O. Railroad; thence along said
right-of-way south $34^{\circ} 35' 16''$ West 622.74 feet to an iron pin set,
the place of beginning; thence along Parcel 2 the following five (5)
courses and distances, South $50^{\circ} 57' 19''$ East 120.21 feet to an iron
pin set, South $10^{\circ} 19' 58''$ East 324.13 feet to an iron pin set, South
 $78^{\circ} 28' 03''$ West 122.82 feet to an iron pin set, South $1^{\circ} 20' 00''$ East

South right-of-way of B. & O. Railroad; thence along B. & O. right-of-
way on a 1658.82 foot radius curve to the left; the chord of which bears
North $39^{\circ} 54' 39''$ East 364.69 feet to a point; thence along said right-
of-way North $14^{\circ} 35' 16''$ East 298.69 feet to the place of beginning,

and distances, North $87^{\circ} 26' 28''$ West 218.17 feet to an iron pin set
and South $78^{\circ} 37' 22''$ West 1109.80 feet to an iron pin set; thence along
State of Ohio North $45^{\circ} 12' 30''$ West 171.78 feet to an iron pin set;
thence along D. E. & P. A. McFee, Vol. 1022, Page 85, Vol. 777, Page
168 and Vol. 740, Page 21, the next six (6) courses and distances, North
 $72^{\circ} 59' 55''$ East 163.53 feet to an iron pin found, North $58^{\circ} 54' 57''$
East 88.40 feet to an iron pin found, North $31^{\circ} 00' 26''$ West 491.29
feet to an iron pin found, South $59^{\circ} 13' 29''$ West 82.73 feet to an
iron pin found, North $69^{\circ} 37' 10''$ West 288.92 feet to an iron pin found
and North $68^{\circ} 51' 11''$ West 21.13 feet to a point in center of South
Mooseye Road; thence along the center of South Mooseye Road North 14°
 $05' 49''$ West 121.78 feet to a point; thence along center of road North
 $21^{\circ} 55' 49''$ West 20.67 feet to a point; thence along Parcel 1 the following
five (5) courses and distances, North $78^{\circ} 04' 12''$ West 434.64 feet
to an iron pin set passing an iron pin set at 11.88 feet, North $11^{\circ} 20'$
 $00''$ West 161.01 feet to an iron pin set, North $78^{\circ} 28' 03''$ East 722.82
feet to an iron pin set, North $10^{\circ} 19' 58''$ West 324.13 feet to an iron
pin set and North $50^{\circ} 57' 19''$ West 120.21 feet to an iron pin set on
the B. & O. Railroad right-of-way;

thence along the right-of-way of B. & O. railroad North 34° 35' 16" East 243.17 feet to an iron pin set on the corner of a 4.035 acre parcel of said B. & O. railroad; thence along parcel of said B. & O. Railroad the next three (3) courses and distances, South 89° 06' 35" East 393.32 feet to an iron pin set, North 34° 35' 16" East 290.77 feet to an iron pin set and North 15° 24' 44" West 427.17 feet to an iron pin set on right-of-way line of B. & O. Railroad; thence on a 3729.22 foot radius curve to the right along B. & O. Railroad the chord of which bears North 43° 56' 49" East 1137.64 feet to an iron pin set; thence leaving said railroad South 3° 06' 24" East 810.62 feet to the place of beginning, containing 71.90 acres more or less.

Bearings are based on the East line of the Southwest Quarter of Section 8 bearing South 2° 19' 29" East.

Being part of Auditor's Parcel Number 66-66-10-08-36-000 and all of Auditor's Parcel Number 66-66-10-08-35-001.

Iron pins set are No. 5 reinforcing bars 30 inches long with plastic I. D. caps.


