THENCE WITH THE EAST LINE OF SAID LUBURGH TRACT, NORTH 02 DEGREES 40 MINUTES 08 SECONDS WEST 1003.82 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR) AT THE NORTHWEST CORNER OF THE SOUTHEAST QUARTER OF SECTION 8;







 thence along the north line of said southeast quarter South 86 degrees 40 minutes 10 seconds West 2653.39 feet to a point;
 thence leaving said north line of said southeast quarter South 34 degrees 24 minutes 19 seconds East 1394.21 feet to a point;
 thence North 84 degrees 58 minutes 52 seconds East 651.44 feet to a point;
 thence North 58 degrees 26 minutes 30 seconds East 160.12 feet to an iron pin found;
 thence South 26 degrees 41 minutes 05 seconds East 240.51 feet to an iron pin found, being the **principle place of beginning** for this parcel;



