Commencing at a 2" pipe found at the northeast corner of said section 8; thence **S1°49'37"W** (The base of bearings for this description is State Plane Grid from a Solar Observation) along the east line of said section 8 a distance of **2142.82** feet to a point in the center of Homestead Dr. at the **True Place of Beginning** for the following described parcel and passing through an iron pin found at **2122.82** feet; thence **S 1°50'05"W** along the east line of said section and along Camp Ln. and along the west line of property owned by Dennis and Nancy Moffitt (O.R. 1152, Pg. 462) a distance of **501.55** feet to an iron pin found in the west part of said Camp Ln. at the southeast corner of said northeast quarter of section 8; thence **N 88°28'14"W** along the half section line and the north line of property owned by John and Jennie Woodruff (O.R. 2135, Pg. 511) a distance of **1473.35** feet to an iron pin found; thence **N 1°28'05"E** along the east line of property owned by Walter and Leona Smith (O.R. 1882, Pg. 591) a distance of **822.78** feet to an iron pin found No. 5792; thence **N 80°09'34"E** along the southerly line of an 18 acre parcel owned by Kay B. Hudson (Vol. 1068, Pg. 542) a distance of **183.00** feet to an iron pin found; thence **S 15°59'26"E** along the west line of a parcel owned by Susan B. Roderick (O.R. 2036, Pg. 749) a distance of **507.43** feet to an iron pin found; thence **N 88°28'18"W** and through the land of Susan B. Roderick and Kay B. 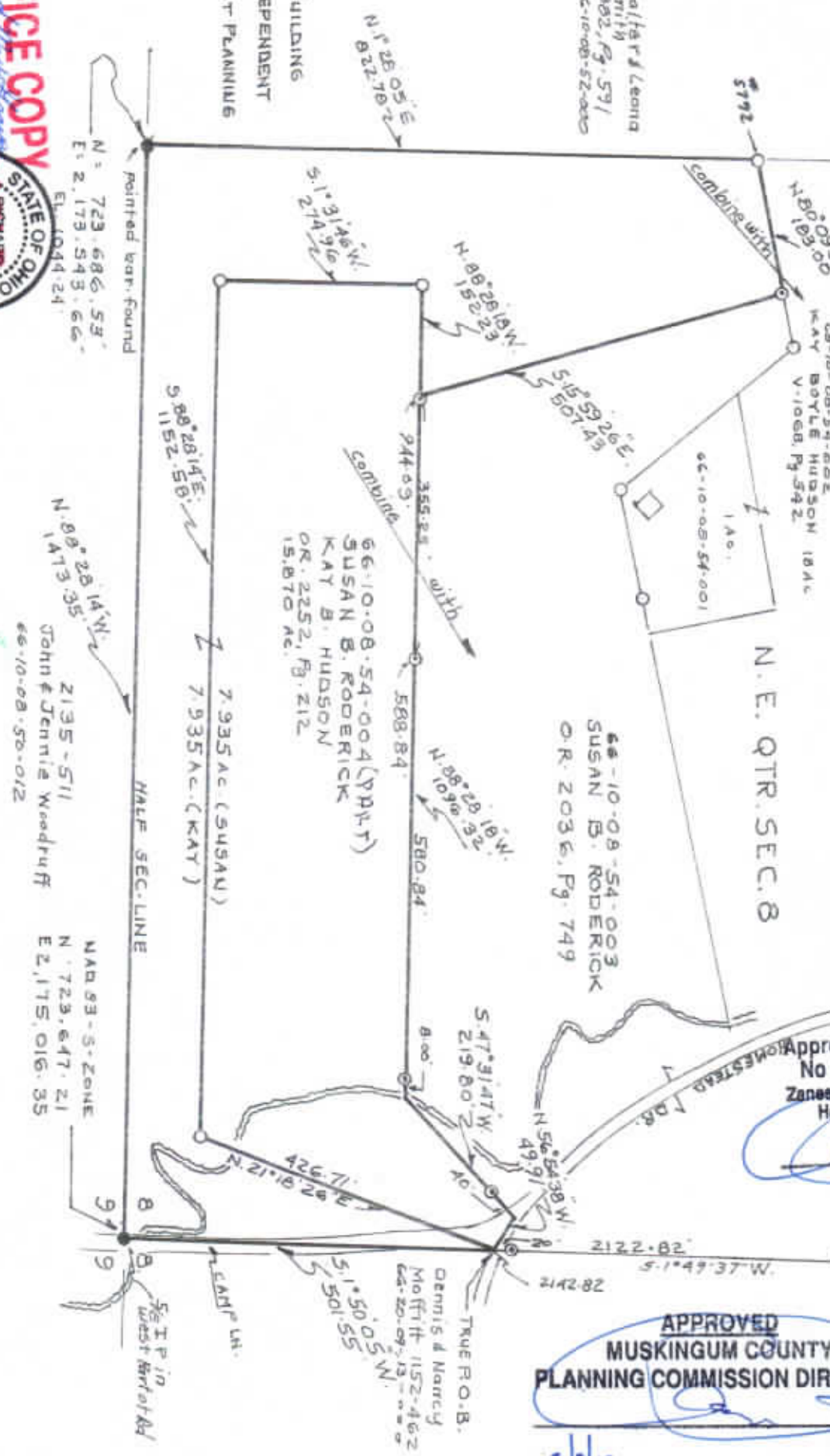
