- TIE- THENCE South 01 degrees 57 minutes 09 seconds West 1219.87 feet along the common line for Sections 7 and 8 to the unmarked common corner for said Ireton property and for the Robert W Camp property recorded in Official Record Volume 2171, Page 562, located in the roadbed of North Moose Eye Road, being the place of beginning for the property herein intended to be described;
- #1- THENCE South 01 degrees 57 minutes 09 seconds West 315.93 feet leaving said roadbed, continuing along said Section line and along the common line for said Ireton property and for the Charles E Snyder and Deborah Snyder property recorded in Official Record Volume 2241, Page 174 to an unmarked point in the centerline of Norwich Drive, passing an iron pin (set) at 231.44 feet;
