Commencing at the Southwest corner of the Southwest Quarter of Section seven; thence North 01 degree 25 minutes 31 seconds East 1579.28 feet to a point seven feet South of the South pavement-curb of Township Road number 66 (Old National Road); thence North 89 degrees 38 minutes 00 seconds East 562.55 feet along a line being seven feet South of and parallel with the said South pavement-curb to a point marked by an iron pin set (5/8 inch X 30 inch rebar), said point being the place of beginning of this tract, passing a point marked by an existing iron pin (3/4 inch pipe) at 115.50 feet and passing a point marked by an existing iron pin (1/2 inch pipe) at 353.09 feet; thence continuing North 89 degrees 38 minutes 00 seconds East 229.25 feet along the said line seven feet South of and parallel with the South pavement-curb to a point marked by an existing iron pin (1/2 inch I. D. pipe); thence South 50 degrees 45 minutes 00 seconds West 226.30 feet along the West right-of-way line of Township Road number 692 (The Chio-United States Highway opened about 1940) to a point marked by an iron pin set (5/8 inch x 30 inch rebar); thence North 20 degrees 51 minutes 39 seconds West 151.65 feet to the place of beginning.


