S located in the Township of Union, County of Muskingum, State of Ohio and being 16.067 acres more or less in the east half of Section # 10, Township # 1 North, Range # 5 West of the United States military Lands Survey and being more particularly described as follows:

Converning at an iron pin found at the Southeast corner of the Northeast Quarter of Section # 10, Thence with the south line of the Northeast Quarter of Section # 10 S 87° 13' 10" W a distance of 917.41 feet to an iron pin found the BEGINNING, Thence with the lands of now or formerly Russell Neck as found in Volume 516 Page 41 of the deed records of Muskingum County, Ohio the following two (2) calls:
