Waltz as found in Volume 1085 Page 25 N 88° 59' 17" W a distance of 221.55 feet to an iron pin set on the west line of the Northwest Quarter of Section # 2 ( having passed through an iron pin set at 196.55 feet ), Thence with the west line of the Northwest Quarter of Section # 2 and in Maple Brook Road N 02° 35' 31" E a distance of 280.38 feet to the beginning and containing 1.241 acres more or less and being a part of the property conveyed to William Waltz as found in Volume 1085 Page 25. Part of AUT. PARCEL # 66-66-20-02-32.000





