Alley as found in Volume 574 Page 623 of the deed records of Muskingum County, Ohio N 85° 19' 48" W a distance of 1313.42 feet to an iron pin set, Thence with the lands of now or formerly D. L. Green as found in Volume 684 Page 289 of the deed records of Muskingum County, Ohio N 04° 35' 30" E a distance of 1280.00 feet to an iron pin set on the south line of B. & O. Railroad, Thence with the south line of said Railroad N 80° 23' 18" E a distance of 1362.00 feet to an iron pipe found, Thence with the lands of now or formerly General Electric Company as found in Volume 489 Page 77 of the deed records of Muskingum County, Ohio S 05° 18' 02" W a distance of 411.70 feet to an iron pipe found, Thence with the lands of now or formerly R. & M. Russell as found in Volume 546 Page 453 of the deed records of Muskingum County, Ohio S 04° 40' 48" W a distance of 1204.32 feet to the beginning and containing 43.70 acres more or less and being all the property conveyed as 43.96 acres as Aut. Parcel # 66-66-20-09-10.000.

Subject to all easements or leases of public record.


Bearings are magnetic and are for angle purposes only.


