- TIE- THENCE North 87 degrees 40 minutes 48 seconds West 528.00 feet along the common line for said Northeast and Southeast Quarters of Section 9 to an iron pin (found) at the place of beginning for the property herein intended to be described, passing an iron pin found at 231.05 feet;
- #1- THENCE North 87 degrees 40 minutes 48 seconds West 215.60 feet continuing along said Quarter Section line to an iron pin (set);

- #6- THENCE North 63 degrees 39 minutes 26 seconds East 17.10 feet continuing along said properties to an iron pipe (found) at a corner of the Crooked Creek Cemetery property recorded in DB "F", Page 53 and Deed Book Volume 132, Page 366;
