- 4) North 04 degrees 07 minutes 29 seconds West 88.33 feet to a disturbed iron pin found 69.6 feet left of State Route 83 centerline station 33+53.6;

thence through Highway Easement Parcel No. 5, South 25 degrees 13 minutes 20 seconds East 254.13 feet to a capped iron pin set on the line common to said Parcel No. 1 and Parcel No. 5, 96.7 feet left of State Route 83 centerline station 31+00.9;

thence through said Parcel No. 1, South 25 degrees 13 minutes 20 seconds East 21.12 feet to a capped iron pin set 99.0 feet left of State Route 83 centerline station 30+79.9;
