Ford and Velma O. Ford (Deed Book 661, Page 117); thence North 86 degrees 43 minutes 09 seconds West along the line of said Ford land 175.55 feet to an iron pin found; thence North 03 degrees 05 minutes 40 seconds East along the easterly line of said Ford land 450.00 feet to an iron pin found at the southwest corner of a 5.00 acre tract of land conveyed to George R. and Margie J. Wilfong (Deed Book 621, Page 284); thence South 86 degrees 49 minutes 20 seconds East along the southerly line of said Wilfong land 143.03 feet to an iron pin found; thence South 69 degrees 49 minutes 18 seconds East along said Wilfong line 50.02 feet to an iron pin found; thence North 47 degrees 22 minutes 56 seconds East along the southeasterly line of said Wilfong land 279.19 feet to a point; thence South 17 degrees 49 minutes 03 seconds East 85.98 feet to a point; thence South 33 degrees 13 minutes 40 seconds East 100.33 feet to a point; thence South 43 degrees 43 minutes 40 seconds East 56.83 feet to a point; thence South 79 degrees 43 minutes East 110.89 feet to a point; thence South 16 degrees 38 minutes 40 seconds East 60.96 feet to a point; thence South 34 degrees 51 minutes 20 seconds West 96.83 feet to a point; thence South 08 degrees 38 minutes 40 seconds East 263.32 feet to a point; thence South 17 degrees 21 minutes 20 seconds West 103.80 feet to a point; thence South 31 degrees 09 minutes 38 seconds East 201.31 feet to a point; thence South 09 degrees 01 minutes 30 seconds West 60.69 feet to the True Place of Beginning, the last 10 courses being along the north and easterly side of the creek.
