COMMENCING AT AN IRON PIN SET AT THE SOUTHWEST CORNER OF LOT 6 OF TAVENNER FARMS SUBDIVISION AS RECORDED IN PLAT BOOK 5, PAGES 8, 9 & 10;

THENCE LEAVING SAID SOUTHWEST CORNER OF LOT 6, WITH THE SOUTH LINE OF SAID LOT 6, SOUTH 87 DEGREES 42 MINUTES 02 SECONDS EAST 445.00 FEET TO AN IRON PIN SET;

THENCE WITH THE WEST LINE OF SAID LOT 6, SOUTH 16 DEGREES 17 MINUTES 10 SECONDS EAST 66.26 FEET TO A POINT, SAID POINT BEING THE PLACE OF BEGINNING FOR THE TRACT HEREIN INTENDED TO BE DESCRIBED;

THENCE CONTINUING WITH SAID WEST LINE OF LOT 6, SOUTH 16 DEGREES 17 MINUTES 10 SECONDS EAST 125.76 FEET TO AN IRON PIN SET ON THE NORTH RIGHT OF WAY OF MABEL D. TAVENNER MEMORIAL BOULEVARD;

THENCE WITH THE NORTH RIGHT OF WAY LINE OF SAID MABEL D. TAVENNER MEMORIAL BOULEVARD THE FOLLOWING THREE COURSES AND DISTANCES:

1. WITH AN ARC TO THE LEFT HAVING A RADIUS OF 58.09 FEET (CHORD BEARING SOUTH 47 DEGREES 23 MINUTES 21 SECONDS WEST 56.70 FEET) AN ARC DISTANCE OF 59.23 FEET TO AN IRON PIN SET;
2. SOUTH 18 DEGREES 10 MINUTES 41 SECONDS WEST 102.58 FEET TO AN IRON PIN SET;
3. SOUTH 28 DEGREES 39 MINUTES 00 SECONDS WEST 41.33 FEET TO AN IRON PIN SET;

THENCE LEAVING SAID NORTH RIGHT OF WAY LINE, NORTH 86 DEGREES 26 MINUTES 17 SECONDS WEST 221.13 FEET TO A POINT;

THENCE NORTH 02 DEGREES 33 MINUTES 53 SECONDS WEST, PASSING AN EXISTING IRON PIN (5/8 INCH REBAR) AT 10.53 FEET, A TOTAL DISTANCE OF 176.10 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR) AT THE NORTHEAST CORNER OF A TRACT CONVEYED TO K. FARQUHAR (DEED VOLUME 1126, PAGE 746).

THENCE LEAVING SAID NORTHEAST CORNER, NORTH 70 DEGREES 13 MINUTES 07 SECONDS EAST, PASSING AN IRON PIN SET AT 268.70 FEET, A TOTAL DISTANCE OF 304.84 FEET TO THE PLACE OF BEGINNING.




