Thence North 74°18'38" East, a distance of 173.35 feet to a point in the centerline of State Route 83 (formerly known as State Route 76);

Thence along the centerline of said State Route 83 South 11°23′22″ East, a distance of 283.80 feet to a iron pin on the south right of way of Westview Drive;

Thence along the south line of said Westview Drive South 80°53′38″ West, a distance of 524.18 feet to a 3/4 inch pipe found;

Thence South 78°59'38" West, a distance of 16.16 feet to a capped rebar set on the west line of a 16 foot wide alley, the POINT OF BEGINNING of the parcel herein described;

Thence along the easterly line of the subject parcel and the westerly line of said 16 foot alley South 01°42′18″ East, a distance of 79.00 feet to a capped rebar set on the northerly line of a parcel of land now or formerly conveyed to Vishnu P. & Sudha S. Thence along the southerly line of the subject parcel and the northerly line of said Saksena, South 78°47′05″ West, a distance of 81.08 feet to a capped rebar set on the easterly right of way of Highland Drive, also being the southwesterly corner of the subject parcel and the northwesterly corner of said Saksena;
