

ADAMS IN O.R. VOLUME 2625, PAGE 876 OF THE MUSKINGUM COUNTY OFFICIAL RECORDS. SITUATED IN THE SOUTHEAST QUARTER OF SECTION 2 AND THE SOUTHWEST QUARTER OF SECTION 1, TOWNSHIP 1, RANGE 5, OF THE UNITED STATES MILITARY LANDS, UNION TOWNSHIP, VILLAGE OF NEW CONCORD, MUSKINGUM COUNTY, OHIO.

BEARINGS ARE BASED ON OHIO STATE PLANE COORDINATE SYSTEM 1983(2011), OHIO SOUTH ZONE, GRID, DERIVED FROM A GPS OBSERVATION.




NOTE 1: THE QUARTER SECTION CORNER (3/4" PIPE) AS SHOWN IS BASED ON THE PREVIOUS SURVEYS BY J.T. SPILKER IN 1999 AND BY C.R. HARKNESS IN 2017. PREVIOUS SURVEYS BY T.J. FINLEY IN 2013, J.D. NEWCOME IN 2016, T.H. LINN IN 2013 AND J.E. DEITRICK IN 2021 ALL USE THE EXISTING STONE. THE EXISTING REBAR WITH ALUMINUM SPILKER CAP IS OF UNKNOWN ORIGIN, AND IS NOT REFERENCED IN ANY THE RESEARCH CONDUCTED FOR THIS SURVEY. THIS ALUMINUM CAPPED PIN WAS ALSO NOT FOUND BY THIS SURVEYOR IN PAST VISITS TO THIS QUARTER SECTION. ADDITIONAL RESEARCH AND FIELD LOCATION IS REQUIRED TO RESOLVE THE TRUE LOCATION OF THIS QUARTER SECTION.

NOTE 2: THE PREVIOUS SPILKER SURVEYS (LOT 1 AND LOT 3 OF BLOCK D) DO NOT INDICATE AN ANGLE POINT ON THE SOUTH LOT LINE AT THE SECTION LINE. THE ANNEXATION PLAT OF THIS SUBDIVISION APPEARS TO SHOW AN ANGLE POINT AT THE SECTION LINE ON THE SOUTH LINE OF THE SUBJECT PARCEL. NO ANGLE POINT WAS CREATED FOR THIS SURVEY.
