Commencing at an iron pin at the Southeast corner of the Northeast Quarter of Section 2; thence north 5 degrees 24 minutes 52 seconds east 1371.03 feet to a stone found and the true place of beginning of the premises herein intended to be described; thence north 86 degrees 17 minutes 08 seconds west 228.64 feet to an iron pin on the east line of State Route #83; thence along the east line of State Route #83 north 0 degrees 13 minutes 49 seconds east 130 feet to an iron pin; thence north 80 degrees 16 minutes 15 seconds east 245.26 feet to an iron pin; thence south 7 degrees 47 minutes 33 seconds east 146.25 feet to an iron pin; thence south 79 degrees 55 minutes 57 seconds west 31 feet to an iron pin; thence south 5 degrees 24 minutes 52 seconds west 36.10 feet to the true place of beginning, containing ninety hundredths (0.90) of an acre more or less.



