Situated in the Village of New Concorde, Muskingum County, Ohio. Being the lands conveyed to Barbara Bash in Deed Book 826 page 086 and deed book 996 page 70 of the Muskingum County deed records and being described as follows:

Beginning at a set rebar located 37.00 feet right of station 26+42.00 of U.S. Route 40;

thence, N.83°50'00"E. a distance of 66.00 feet along the south line of Main Street to a set rebar at the Northwest corner of the lands, now or formerly, owned by A. Duncan (1057/152);

thence, S.03°39'55"E. a distance of 94.00 feet along the west line of said Duncan lands to a set rebar on the North line of the CSX railroad, formerly the B. & O. railroad;

thence, S.86°20'05"W. a distance of 66.00 feet along the North line of said railroad to a found iron pin on the Southeast corner of the lands, now or formerly, owned by F. Ackerman (504/270);

thence, N.03°37'32"W. a distance of 91.13 feet along said Ackerman lands to the point of beginning.

The above described parcel contains 0.140 acres, more or less, and is subject to all legal easements and right of ways. All set. All set rebars are 5/8" x 30" rebars. North is based an assumed meridian.
