Being the premises described in Muskingum County Deed Vol. 1145, Page 948, part of the Southwest Quarter of Section 1, Township 1, Range 5, bounded and described as follows;

Beginning for reference at an iron pipe found at the Northwest corner of lot #3 of the Town of Concord, DR "T", Pg. 526

thence along the South line of Main Street South 82 deg. 40 min. 00 sec. West 85.37 feet to a point at the Northeast corner of lot #1 of Findley's Addition to Concord, DR 16, Pg 3, being the principal place of beginning;

thence South 07 deg. 01 min. 50 sec. East 203.87 feet to an iron pin set (passing an iron pipe found disturbed at 0.09 feet);

thence South 82 deg. 56 min. 25 sec. West 152.28 feet to a P.K. nail set;

thence North 07 deg. 03 min. 42 sec. West 123.74 feet to a Railroad Spike found;

thence North 83 deg. 00 min. 47 sec. East 30.40 feet to point (passing an iron pin set at 28.40 feet);

thence North 07 deg. 04 min. 02 sec. West 79.59 feet to a iron pin found;

thence along the South line of Main Street North 82 deg. 40 min. 00 sec. East 122.00 feet to the place of beginning and containing 0.66 acres, more or less.

Iron pins set are one half inch rebar, 30 inches long with yellow ID cap stamped DAVIS # 7972;

Subject to all legal right of ways, easements, restrictions, zoning regulations either written or implied and any pertinent facts disclosed from a full and accurate title search including railroad easements and right-of-ways.

The bearings for this survey are for angle calculations only and are based on the South line of Main Street being South 82 deg. 40 min. 00 sec. West.

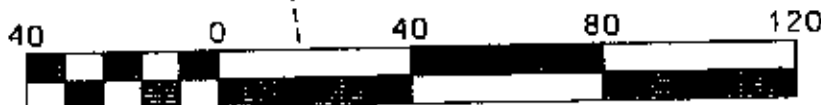
