

Description To Vacate Property George and Tokiko Shegog

Situated in the State of Ohio, County of Muskingum, Union Township.

Being a part of the Village of New Concord, Lots 14 and 15 of Russells Addition (Plat Book 1, Page 177), Part of Lot 9 in West Concord Subdivision (Plat Book 1, Page 155) and alleys vacated by Ordinance Number G-9-80-1 Village of New Concord bounded and described as follows:

Beginning at the northeast corner of Lot 15 of Russells Addition; thence south 1 degree 57 minutes 12 seconds east 6.30 feet to the northwest corner of Lot 9 of West Concord Subdivision; thence along the north line of said Lot 9 north 88 degrees 01 minutes east 184.12 feet to an iron pin; thence south 1 degree 59 minutes east 86.70 feet to an iron pin; thence south 88 degrees 49 minutes east 75.65 feet to an iron pin; thence south 2 degrees 04 minutes east 63 feet to an iron pin; thence south 77 degrees 24 minutes east 28.90 feet to an iron pin; thence south 5 degrees 19 minutes east 18.20 feet to an iron pin on the northerly right of way line of the B. & O. Railroad; thence along said right of way line on a curve to the left having a radius of 8657.37 feet an arc distance of 455.95 feet (the chord of which bears north 85 degrees 05 minutes 50 seconds west 455.90 feet) to a point; thence north 11 degrees 27 minutes 01 seconds west 126.53 feet to a point; thence north 1 degree 59 minutes west 6.77 feet to a point; thence north 88 degrees 36 minutes 55 seconds east 52.48 feet to a point; thence north 88 degrees 36 minutes 55 seconds east 52.48 feet to a point; thence north 88 degrees 01 minutes east 132 feet to the place of beginning, containing one the thirty-five hundredths (1.35) acres more or less.
