Being a part of the Southeast Quarter of Section 15, Township 1, Range 5 bounded and described as follows:

Commencing at a stone found at the Southeast corner of Section 15; thence north 7 degrees 36 minutes 54 seconds east 1375.86 feet to an iron pin; thence north 59 degrees 56 minutes west 472.74 feet to a point in the center of Sundale Road; thence along the center of said road south 41 degrees 17 minutes 08 seconds west 234.55 feet to a point in said centerline and the true place of beginning of the premises herein intended to be described; thence continuing along said centerline south 42 degrees 24 minutes 09 second west 477.70 feet to a point; thence leaving said road north 72 degrees 59 minutes 51 seconds west 217.47 feet to an iron pin; thence north 56 degrees 55 minutes 30 seconds west 272.83 feet to an iron pin; thence north 7 degrees 36 minutes 01 seconds east 520.40 feet to an iron pin found; thence south 61 degrees 26 minutes 11 seconds east 785.50 feet to the true place of beginning, containing seven and twelve hundredths (7.12) acres more or less.




