VOLUME 2801, PAGE 805) OF THE MUSKINGUM COUNTY OFFICIAL RECORDS. SITUATED IN THE NORTHWEST QUARTER OF SECTION 12, TOWNSHIP 1, RANGE 5, OF THE UNITED STATES MILITARY LANDS, UNION TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

COMMENCING AT AN IRON PIN (1/2 INCH PIPE) AT THE NORTHWEST CORNER OF SECTION 12;

THENCE WITH THE NORTH LINE OF THE SAID SECTION 12 (SOUTH LINE OF A PARCEL CONVEYED TO TERRI J. HERRON AND BRIAN S. HEWISON IN O.R. VOLUME 3069, PAGE 179), SOUTH 87 DEGREES 50 MINUTES 58 SECONDS EAST 606.00 FEET TO AN IRON PIN SET, SAID IRON PIN SET BEING THE **PLACE OF BEGINNING** FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED:

THENCE CONTINUING WITH THE SAID SECTION LINE (SOUTH LINE OF THE SAID HERRON AND HEWISON PARCEL), SOUTH 87 DEGREES 50 MINUTES 58 SECONDS EAST 198.03 FEET TO A POINT IN THE CENTER OF CHUCK LANE (TOWNSHIP ROAD 202), PASSING AN IRON PIN SET AT 134.65 FEET;

THENCE LEAVING THE SAID SECTION LINE AND WITH THE CENTER OF THE SAID ROAD THE FOLLOWING FIVE COURSES AND DISTANCES:

1. SOUTH 27 DEGREES 09 MINUTES 31 SECONDS EAST 46.66 FEET TO A POINT;
2. SOUTH 42 DEGREES 05 MINUTES 04 SECONDS EAST 45.64 FEET TO A POINT;
3. SOUTH 49 DEGREES 00 MINUTES 19 SECONDS EAST 50.94 FEET TO A POINT;
4. SOUTH 59 DEGREES 26 MINUTES 40 SECONDS EAST 59.12 FEET TO A POINT;
5. SOUTH 70 DEGREES 46 MINUTES 33 SECONDS EAST 37.46 FEET TO A POINT;

THENCE LEAVING THE CENTER OF THE SAID ROAD AND TRAVERSING THROUGH THE ABOVE SAID AITKEN PARCEL THE FOLLOWING TWO COURSES AND DISTANCES:

1. SOUTH 66 DEGREES 45 MINUTES 42 SECONDS WEST 233.99 FEET TO AN IRON PIN SET, PASSING AN IRON PIN SET AT 60.00 FEET;
2. NORTH 88 DEGREES 01 MINUTES 54 SECONDS WEST 167.53 FEET TO AN IRON PIN SET ON THE EAST LINE OF A PARCEL CONVEYED TO THE EMMA JOANN MURREY REVOCABLE TRUST DATED JULY 18, 1996 (EMMA JOANN MURREY, TRUSTEE) IN O.R. VOLUME 2163, PAGE 825;

THENCE WITH THE EAST LINE OF THE SAID MURREY PARCEL, NORTH 01 DEGREES 51 MINUTES 02 SECONDS EAST 245.32 FEET TO THE **PLACE OF BEGINNING**.
