Being a part of Section 9 and 12 in Township 1, Range 5 bounded and described as follows:


Beginning at the northwest corner of the northeast quarter of Section 12; thence north 2 degrees 24 minutes 54 seconds east 373.32 feet to a point on the south right of way line of Interstate Route 70; thence along said right of way line south 87 degrees 57 minutes 53 seconds east 343.56 feet to a point in the center of Rix Mills Road; thence along the center of Rix Mills Road south 27 degrees 06 minutes 14 seconds west 222.67 feet to a point; thence continuing along the center of said road on a curve to the right having a radius of 881.47 feet an arc length of 163.71 feet (the chord of which bears south 34 degrees 57 minutes 55 seconds west 163.47 feet) to a point; thence continuing along said centerline the following five (5) courses and distances, south 41 degrees 41 minutes 05 seconds west 52.44 feet to a point; thence south 44 degrees 32 minutes 45 seconds west 52.21 feet to a point; thence south 46 degrees 42 minutes 33 seconds west 50.95 feet to a point; thence south 47 degrees 55 minutes 23 seconds west 51.42 feet to a point; thence south 48 degrees 50 minutes 45 seconds west 29.02 feet to a point; thence leaving said road north 1 degree 57 minutes 27 seconds east 136.34 feet to the place of beginning, containing two and thirty-one hundredths (2.31) acres more or less, and being 2.09 acres in Section 9 and 0.22 acres in Section 12.
