

**DEED DESCRIPTION
FOR
BRIAN DALEY**

Situated in the Township of Union, County of Muskingum, State of Ohio, and being 5.820 acres more or less in the Northeast Quarter of Section # 18, Township # 1 North, Range # 5 West of the United States Military Lands Survey and being more particularly described as follows:

Commencing at the Northeast corner of the Northeast Quarter of Section # 16, Thence with the north line of the Northeast Quarter of Section # 16 N 89° 42' 19" W a distance of 1298.69 feet to a point, Thence S 01° 20' 01" W a distance of 834.32 feet to a point, Thence S 27° 09' 26" W a distance of 386.99 feet to a point in the center of Sundale Road the **BEGINNING**, Thence with the center of Sundale Road and the lands of now or formerly P. Allen as found in Volume 1017 Page 17 the following two (2) calls:

1. S 27° 09' 26" W a distance of 353.69 feet to a point.
2. S 36° 39' 23" W a distance of 45.19 feet to a point, Thence with a new division line through the lands of now or formerly D. Allen as found in Volume 1068 Page 495 the following two (2) calls:

1. N 70° 27' 18" W a distance of 321.19 feet to an iron pin set (having passed through an iron pin set at 14.87 feet).
2. N 08° 13' 19" W a distance of 725.52 feet to a point in the center of Zane Trace Road, Thence with the lands of now or formerly R. Radcliffe as found in Volume 1070 Page 537 S 51° 25' 04" E a distance of 760.96 feet to the beginning (having passed through an iron pin found at 17.00 feet and 746.66 feet) and containing 5.820 acres more or less. Described as follows;



1. N 63° 43' 12" W a distance of 206.55 feet to a point.
2. N 72° 07' 41" W a distance of 48.76 feet to a point.
3. S 84° 40' 46" W a distance of 65.29 feet to a point.
4. S 56° 16' 28" W a distance of 55.33 feet to a point.
5. S 33° 24' 37" W a distance of 86.70 feet to a point on the west line of the above described property (said point is located N 08° 13' 19" W a distance of 35.00 feet from an iron pin set at the southwest corner of the above described property.

Iron pins set are 5/8 inch rebar 30 inches long, capped SPILKER LS-5862.


