

Thence North 89 degrees 29 minutes 14 seconds East 556.46 feet to a point. Thence South 00degrees 30 minutes 46 seconds East 339.22 feet to a 5/8" iron pin set, said pin being the place of beginning for the tract herein described. Thence North 89 degrees 29 minutes 14 seconds East 466.70 feet to a 5/8" iron pin set. Thence South 00 degrees 30 minutes 46 seconds East 466.69 feet to a 5/8" iron pin set. Thence South 89 degrees 29 minutes 14 seconds West 466.70 feet to a 5/8" iron pin set. Thence North 00 degrees 30 minutes 46 seconds West 466.69 feet to the place of beginning containing 5.0001 acres more or less. Subject to all right of ways and easements ether written or implied. All iron pins set are 5/8" by 30" rebar with I.D. caps stamped Walton S-7675. Bearings based on a previous survey by Earl R. Donaker dated May 1991, and are for angular calculation only. 


