

Cunningham (VOL. 725, Pg. 301) North 64 degrees 16 minutes 49 seconds East 203.51 feet to an iron pin set; thence North 73 degrees 25 minutes 17 seconds East along said road and the North line of said 3 acres a distance of 419.19 feet to an iron pin set; thence South 10 degrees 33 minutes 45 seconds East along the East line of said 3 acres and the Westerly line of said Cunningham 180.67 feet to a point in the center of a creek and passing through an iron pin set at 155.67 feet; thence South 49 degrees 08 minutes 22 seconds West along the center of said creek and the Easterly line of said 3 acres 83.52 feet to a point on the South line of the Southwest quarter of fractional section 18, and the North line of the Northwest quarter of fractional section 23, said pin bears South 87 degrees 28 minutes 24 seconds East 25.00 feet from an iron pin set on the West side of said creek; thence South 87 degrees 29 minutes 24 seconds East along said section line between the North line of section 23 and the South line of the section 18 a distance of 1016.86 feet to an iron pin set in the center of Hardesty Road; thence North 20 degrees 08 minutes 07 seconds West along the East line of said Edith Cunningham (VOL. 725, Pg. 301) a distance of 308.94 feet to an iron pin set in said Hardesty Road; thence North 19 degrees 22 minutes 30 seconds East along the East line of said Cunningham Property and along said Hardesty Road 841.26 feet to an iron pin set in the East side of said road bed; thence North 12 degrees 38 minutes 09 seconds East along the East side of said Cunningham property 570.02 feet to a stone found and passing through an iron pin set at 65.00 feet and a stone found at 241.83 feet; thence North 4 degrees 41 minutes 10 seconds East along the East side of said Cunningham property 984.52 feet to a stone found on the North line of said Southwest quarter of section 18; thence South 87 degrees 20 minutes 48 seconds East along the North line of said quarter and the South line of Beula Dickson (VOL. 623, Pg. 172) a distance of 613.80 feet to an iron pin set in a creek on the East line of said Southwest quarter of section 18 and on the West line of Lot 15 and passing through a stone found at 285.39 feet; thence North 2 degrees 30 minutes 26 seconds east along the east line of the Northeast quarter of said section 18 and the West line of said Lot 15 a distance of 193.38 feet to the place of beginning containing three hundred ninety and eighty eight hundredths (390.88) more or less.
