PART OF AUDITORS PARCEL
 66-90-04-02-000 (20.05 Acres)

Situated in Lot 10, Quarter Township 4, T-1-N, R-5-W, U.S.M.L., Union Township, Muskingum County, Ohio. Being part of the lands of Carol Goff conveyed in Deed Book 1896 page 663 of the Muskingum County Deed records, being described as follows:

Commencing at a found iron pin in the Southwest corner of Lot 10; Thence, N.00°53'34"E. a distance of 967.42 feet along the West line of lot 10 and along the right of way of Sunflower Road to a point near the centerline of said road, BEING THE POINT OF BEGINNING;

Thence, N.00°53'34"E. a distance of 49.92 feet along the west line of said lot and along said road to a point;

Thence, S.84°46'36"E. a distance of 501.78 feet through the lands of C. Goff (1896/663) to a set rebar, passing a set rebar at 23.76';

Thence, N.00°49'35"E. a distance of 338.30 feet through said Goff lands to a set rebar, on the South line of the lands, now or formerly, owned by R. Mitchell (1670/766);

Thence, S.89°49'29"E. a distance of 1,303.89 feet along said Mitchell lands to a found iron pin;

Thence, N.00°00'16"W. a distance of 807.56 feet along said Mitchell lands to a found iron pin;

Thence, N.56°21'01"E. a distance of 259.46 feet along said Mitchell lands to a found iron pin;

Thence, S.00°00'17"E. a distance of 1,387.23 feet through the lands of C. Goff (1896/663) to a set rebar;

Thence, N.89°49'43"W. a distance of 1,320.22 feet through said Goff lands to a set rebar;

Thence, N.76°58'51"W. a distance of 207.18 feet through said Goff lands to a set rebar;

Thence, N.04°41'27"W. a distance of 505.37 feet through said Goff lands to the point of beginning, passing a set rebar at 481.06 feet.

The above described parcel contains 20.05 acres, more or less, and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.
