Situated in the Township of Union, County of Muskingum, State of Ohio and being 38.294 acres in Military Lot 9 of the Fourth Quarter of Township 1 north Range 5 west of the United States Military District and being more particularly described as follows,

BEGINNING at a 5/8 inch capped rebar found at the northwest corner of said Lot 9 thence with the north line of said lot 9 and with the lands of Joseph E. Yaw as recorded in deed volume 786 page 173 S 88° 08' 37" E a distance of 1806.43 feet to a point on the south edge of Shady Grove Road thence leaving said lot line and with a line through the lands of William L. Marshall as recorded in official records volume 1649 page 616 the next three calls,

1) S 03° 09' 14" W a distance of 135.27 feet to an iron pin set having passed through an iron pin set at 7.76 feet.

2) S 11° 52' 18" W a distance of 550.00 feet to an iron pin set.

3) S 11° 52' 18" W a distance of 623.08 feet to a 5/8 inch capped rebar found thence with the lands of Countrytime Grove City Ltd as recorded in official records volume 2005 page 217 the next three calls,

1) N 65° 35' 02" W a distance of 1062.11 feet to a 5/8 inch capped rebar found.

2) N 63° 12' 39" W a distance of 260.00 feet to an iron pin set.

3) N 63° 12' 39" W a distance of 419.66 feet to an iron pin set having passed through a 5/8 inch capped rebar found at 404.43 feet thence with the west line of said Lot 9 and with the lands of James R. and Kimberly L. Slack as recorded in official records volume 1508 page 532

N 01° 38' 40" E a distance of 596.46 feet to the **BEGINNING** and containing 38.294 acres.
