

DESCRIPTION OF SURVEY FOR KANSAS STATE UNIVERSITY JOB#722-14

Situated in the State of Ohio, County of Muskingum, Township of Union:

Being part of the Lot #7, Township #1, Range #5 of the US Military District, being part of the Kansas State University property as described in Tract One of deed reference Deed Book Volume 1083, Page 641 of said county's deed records, said property known as Muskingum County Auditor's Parcel Number (part) 66-90-04-28-000 and more particularly described as follows;

Commencing at the Southeast corner of said Lot #7, also being the common corner for Lots #8, #13, & #14 of said Township and Range, which is within the Delmus Garber property described in deed reference Deed Book Volume 682, Page 8; thence N 87 56 50 W 174.21 feet along the common line for said Lot #7 & #14 to an iron pin (found) on the West line of said Delmus Garber property, being the place of beginning for the property herein intended to be described;

- #1- thence N 87 56 50 W 399.56 feet continuing along said common Lot line to the center line of County Road #55 (Rix Mills Road), passing an iron pin (found) at 379.56 feet;
- #2- thence N 04 37 20 W 225.73 feet into said Lot #7, along said road, and line of the Darrell Garber property described in deed reference Deed Book Volume 871, Page 218 to an unmarked corner;
- #3- thence S 85 38 50 E 601.24 feet through said Kansas State University property to an iron pin (set) on the common line for said Lots #7 & #8, passing an iron pin (set) at 22.37 feet;
- #4- thence S 02 15 40 W 20.55 feet along said common Lot line to an iron pin (found) at a corner of said Delmus Garber property;
- #5- thence N 87 48 50 W 180.84 feet along the North line of said Delmus Garber property to an iron pin (found) at the Northwest corner of said Delmus Garber property;
- #6- thence S 00 09 30 W 180.03 feet along the West line of said Delmus Garber property to the place of beginning containing 2.12 acres.

The bearings within the description are based on State Plane Coordinate Grid derived from an average of numerous Solar Observation (Local Hour Angle Method). Observations were calculated with a range of + or - 27 seconds. Bearings are shown in a format of Degrees, Minutes, and Seconds. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).






