LEGAL DESCRIPTION

Situated in the State of Ohio, County of Muskingum, Township of Union, and being part of Lot 13 in Township 1, Range 5 of the United States Military Lands, and being part of those lands intended to be described in Deed Volume 2408, page 749; being further bounded and described as follows:

Commencing at an iron pin found at the southwest corner of said Lot 13, thence, north 01 degrees – 59 minutes – 40 seconds east, 415.00 feet, along the west line of said Lot, to an iron pin found; thence, south 82 degrees – 27 minutes – 20 seconds east, 565.84 feet to the **true point of beginning** for the parcel herein intended to be described;

Thence, continuing south 82 degrees – 27 minutes – 20 seconds east, 128.65 feet, along the south line of those lands now or formerly owned by Cynthia Powers (2408/749) and the northerly line of those lands now or formerly owned by W. Hoffman (1549/50), to a magnetic nail found in a post;

Thence, north 20 degrees – 58 minutes – 30 seconds east, 537.47 feet, along the westerly line of those lands now or formerly owned by T. Riggle (2408/744), to an iron pin found;

Thence, north 38 degrees – 19 minutes – 08 seconds west, 403.62 feet, along the westerly line thereof, to an iron pin found;

Thence, with a new division line through aforesaid Cynthia Powers property, south 04 degrees – 58 minutes – 01 seconds west, 804.65 feet to the **point of beginning**, and **containing 3.328 acres more or less.**

Subject to all legal highways and easements, whether recorded or implied.

Bearings described herein are based on assumed azimuth and to be used for angle purposes only.

Not to be used as a separate building site or transferred as an independent parcel in the future without Planning Commission approval in accordance with applicable subdivision regulations.





