COMMENCING AT THE NORTHEAST CORNER OF SAID LOT NUMBER 11 IN THE CENTER OF STATE ROUTE NUMBER 666; THENCE ALONG THE NORTH LINE OF SAID LOT NUMBER 11, SOUTH 81 DEGREES 00 MINUTES 00 SECONDS WEST 1868.76 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR) ON THE WESTERLY RIGHT-OF-WAY OF THE PENNSYLVANIA RAIL ROAD (ABANDONED); THENCE WITH THE SAID RIGHT-OF-WAY, ON A CURVE TO THE LEFT HAVING A RADIUS OF 2880.55 FEET (CHORD BEARING SOUTH 42 DEGREES 16 MINUTES 33 SECONDS EAST 371.33 FEET) AN ARC DISTANCE OF 371.59 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR) AT THE NORTHEAST CORNER OF THE ABOVE SAID MANN TRACT, SAID POINT BEING THE PLACE OF BEGINNING OF THE TRACT HERE INTENDED TO BE DESCRIBED; THENCE CONTINUING WITH THE SAID RIGHT-OF-WAY ON A CURVE TO THE LEFT HAVING A RADIUS OF 2880.55 FEET (CHORD BEARING SOUTH 46 DEGREES 30 MINUTES 42 SECONDS EAST 52.67 FEET) AN ARC DISTANCE OF 52.67 FEET TO AN IRON PIN SET; THENCE LEAVING THE SAID RIGHT-OF-WAY, SOUTH 60 DEGREES 39 MINUTES 01 SECONDS WEST 429.80 FEET TO A POINT ON THE LOW WATER MARK OF THE MUSKINGUM RIVER, PASSING IRON PINS SET AT 126.25 FEET AND 403.71 FEET; THENCE WITH THE SAID LOW WATER MARK, NORTH 41 DEGREES 27 MINUTES 47 SECONDS WEST 219.79 FEET TO A POINT; AT THE NORTHWEST CORNER OF THE ABOVE SAID MANN TRACT; THENCE LEAVING THE SAID LOW WATER MARK AND WITH THE NORTH LINE OF THE SAID MANN TRACT, NORTH 80 DEGREES 19 MINUTES 14 SECONDS EAST 488.91 FEET TO THE PLACE OF BEGINNING, PASSING AN EXISTING IRON PIN (5/8 INCH REBAR) AT 30.00 FEET AND AN IRON PIN SET AT 338.45 FEET.




