THENCE along the east line of said Lot 25 South 02 degrees 49 minutes 20 seconds West for a distance of 720.74 feet to an iron pin set;
THENCE South 74 degrees 26 minutes 27 seconds West for a distance of 219.11 feet to an iron pin set;
THENCE North 02 degrees 48 minutes 59 seconds East for a distance of 800.72 feet to a iron pin set;
THENCE continuing along said line North 02 degrees 48 minutes 59 seconds East for a distance of 15.00 feet to a point in the centerline of Gilbert Road (Twp. Road 392);
THENCE along said centerline of Gilbert Road South 85 degrees 30 minutes 47 seconds East for a distance of 208.00 feet to the east line of Lot 16;
THENCE along said east line of Lot 16 South 02 degrees 32 minutes 09 seconds West for a distance of 19.84 feet to the place of beginning, passing an iron pin found at 18.84 feet; containing 3.72 acres more or less, subject to all applicable right of ways and easements, written or implied.




