

Situated in the State of Ohio, County of Muskingum, Township of Washington, Township 1-N, Range 7-W, Quarter Township 3 and being a part of Lot 2 of Underwoods Subdivision as recorded in Deed Book "E", Page 62 and being further described as follows:

The information for the location of the point of beginning from the northeast corner of said Lot 2 was copied from Deed Book 864, Page 94. Commencing at the northeast corner of said Lot 2, thence, West 1,116.06 feet along the north line of said Lot 2, thence, North 84° West, 1,076.00 feet along the north line of said Lot 2 to a point on the center of Fox Lane at the northwest corner of H. and T. Fesler (Deed Book 916, Page 008), thence with the following three calls to points on the centerline of said Fox Lane and the west line of said H. and T. Fesler, (1) South $2^{\circ} 27'$ East, 211.00 feet; (2) South $1^{\circ} 38'$ West, 217.00 feet; (3) South $8^{\circ} 03'$ East, 100.00 feet; thence leaving Fox Lane, South $84^{\circ} 32'$ East, 20.35 feet to a point at the northwest corner of P. and B. Heil (Deed Book 864, Page 094) thence, South $00^{\circ} 02'$ West, 167.67 feet along a west line of said P. and B. Heil, thence, South $6^{\circ} 12'$ West, 248.20 feet to a point at the southwest corner of said P. and B. Heil, said point also being on the centerline of the Adamsville Road--County Road 694--passing an existing iron pin at 226.78 feet, said corner also being the true point of beginning of the parcel hereiu being described. The following five calls are to points on the centerline of said Adamsville Road, (1) thence, South $85^{\circ} 43' 54''$ East, 734.98 feet, also being on the south line of said P. and B. Heil and H. and T. Fesler (Deed Book 916, Page 008), (2) thence, South $85^{\circ} 24' 01''$ East, 54.78 feet also along the south line of said H. and T. Fesler, (3) thence, South $82^{\circ} 42' 36''$ East, 71.57 feet also along the south line of said H. and T. Fesler, (4) thence, South $79^{\circ} 25' 52''$ East, 61.83 feet also along the south line of said H. and T. Fesler and B. Murphy (Deed Book 709, Page 299), (5) thence, South $73^{\circ} 09' 31''$ East, 44.31 feet also along the south line of B. Murphy, thence, leaving said road South $2^{\circ} 38' 59''$ West, 392.57 feet along a west line of L. Miller (Deed Book 970, Page 010) to an existing stone, passing an iron pin (set) -- $5/8''$ re-bar--at 18.35 feet, thence, North $83^{\circ} 50' 05''$ West, 1,204.16 feet along a north line of said L. Miller and J. and B. Harrier (Deed Book 703, Page 172) to a point, passing an iron pin (set)-- $5/8''$ re-bar--at 1,201.16 feet, thence, North $6^{\circ} 38' 40''$ East, 373.39 feet along the east line of R. and F. Wofter (Deed Book 1001, Page 423) to a point on the centerline
