R. # 694, Thence with the south side of C. R. # 694 N 68° 25' 12" E a distance of 105.77 feet to an iron pin set, Thence with the lands of now or formerly Donald F. Fox as found in Volume 622 Page 6 of the deed records of Muskingum County, Ohio S 03° 30" W a distance of 190.53 feet to an iron pin found, Thence with the lands of now or formerly R. & L. Shinn as found in Volume 760 Page 311 of the deed records of Muskingum County, Ohio S 03° 30' W a distance of 339.96 feet to the beginning and containing 0.983 acres more or less and being all the property conveyed to Samuel A. Minard as found in Volume 655 Page 112 of the deed records of Muskingum County, Ohio and carried as Auditor's Parcel # 70-00944


