2392 EAST PIKE

Situated in Quarter Township 3, T-1, R-7, U.S.M.L., Washington Township, Muskingum County, Ohio. Being part of the lands of William Hague conveyed in Deed Book 1750 page 733 of the Muskingum County Deed Records and being described as follows:

Beginning at the Southeast corner of lot 2 in Eastlynd acres subdivision;

Thence, **N.11°15'00"W.** a distance of **55.94** feet along the east line of said lot 2 to a set rebar;

Thence, **N.82°24'00"E.** a distance of **196.90** feet through the lands of W. Hague (1750/733) and along the South line of A. Swingle (1106/506) to a found iron pin;

Thence, **S.01°44'00"W.** a distance of **224.93** feet along the West line of the lands of C. Luburgh (1062/020) to a found iron pin;

Thence, **S.78°45'00"W.** a distance of **175.92** feet along the South line of the lands of W. Hague (1142/487) to a found iron pin on the East line of Lot 11;

Thence, **N.11°15'00"W.** a distance of **176.00** feet along the East line of lots 11 and 12 to a found iron pin on the South line of lot 2;

Thence, **N.79°10'51"E.** a distance of **29.95** feet along the East line of lots 11 and 12 to the point of beginning.

The above described parcel contains 1.011 acres, more or less, and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.


