a point in the center of State Route #93 (Adamsville Road);
thence South 52 degrees 35 minutes West along the center of
said road 117.4 feet to a point; thence leaving said road North
88 degrees West 310.38 feet to an iron pin; thence South 47
degrees 37 minutes West 203.9 feet to the true place of beginning
of the premises herein intended to be conveyed; thence South
37 degrees 05 minutes East 175.59 feet to a point in the center


