LEGAL DESCRIPTION

Situated in the State of Ohio, County of Muskingum, Township of Washington, and being part of the north half of the northeast quarter of Quarter Township 4, Township 1, Range 7 of the United States Military Lands, and being all those lands intended to be described in Deed Volume 424, page 551; being further bounded and described as follows:

Beginning at an axle found at the southeast corner of Lot #1 of Rolling Green Subdivision, as recorded in Plat Book 9, page 47, thence, south 00 degrees – 08 minutes – 33 seconds east, 78.82 feet to a point in Jackson Road (County Road 191);

Thence, north 86 degrees – 32 minutes – 00 seconds west, 539.87 feet along the north line of those lands now or formerly owned by J.C. & N.L. Bracken, as recorded in Deed Volume 631, page 48, to an axle found, passing an axle found at 10.00 feet;

Thence, north 06 degrees – 32 minutes – 28 seconds east, 80.34 feet, along the east line of said Bracken lands, to an axle found;

Thence, south 86 degrees – 59 minutes – 12 seconds east, 428.61 feet, along the south line Lot #1 of said Rolling Green Subdivision, to an axle found;

Thence, south 83 degrees – 45 minutes – 26 seconds east, 102.12 feet to the **point of beginning**, and containing 1.004 acres more or less.



