OLIVER AS RECORDED IN DEED VOLUME 393, PAGE 97 OF THE
MUSKINGUM COUNTY DEED RECORDS TO A POINT; THENCE NORTH 90
DEGREES 00 MINUTES 00 SECONDS EAST 615 FEET (BY DEED) TO AN
EXISTING AXLE AT THE SOUTHWEST CORNER OF A TRACT CONVEYED TO
G. AND M. MATHES AS RECORDED IN DEED VOLUME 937, PAGE 9 OF
THE SAID COUNTY RECORDS; THENCE SOUTH 64 DEGREES 04 MINUTES
00 SECONDS EAST 19.13 FEET ALONG THE GRANTORS SOUTH LINE TO
AN IRON PIN SET, SAID IRON PIN BEING THE PLACE OF BEGINNING
OF THE TRACT HEREIN INTENDED TO BE DESCRIBED; THENCE LEAVING
SAID SOUTH LINE NORTH 14 DEGREES 41 MINUTES 00 SECONDS EAST
315.83 FEET TO A POINT IN THE CENTER OF TOWNSHIP ROAD 482


