Situated in the State of Ohio, County of Muskingum, Township of Washington.

Being a part of Quarter Township 4, Township 1, Range 7 bounded and described as follows:

Commencing at an iron pin found at the Southeast Corner of Lot 6 in Gerold C. Starrs Snddivision as recorded in Plat Book 9, Page 20; thence crossing State Route #93 (Pleasant Grove Road) south 81 degrees 35 minutes east 117.80 feet to an iron pin found at a point that is 55 feet right of Station 66+19.55 centerline survey done in 1969 of State Route #93 and recorded in Plat File 1, Slot 20 and also being the true place of beginning of the premises herein intended to be described; thence south 89 degrees 05 minutes east 600.25 feet to an iron pin found; thence south 10 degrees 12 minutes 23 seconds west 290.61 feet to an iron pin found; thence south 78 degrees 49 minutes 22 seconds west 106.99 feet to an iron pin; thence north 64 degrees 47 minutes 57 seconds west 224.76 feet to an iron pin; thence north 76 degrees 13 minutes 45 seconds west 321.17 feet to an iron pin that is 40 feet right of Station 64+59.27 of the aforesaid centerline survey; thence along the east right of way line of State Route #93 north 26 degrees 24 minutes 08 seconds east 160.98 feet to the true place of beginning, containing three and twenty-nine hundredths (3.29) acres more or less.
