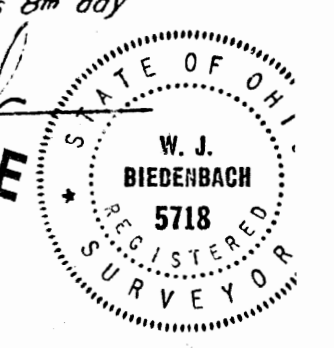
Muskingum County Tax Map
