DESCRIPTION FOR CONVEYANCE

BEING A PART OF THE NORTHWEST QUARTER OF SECTION 6, TOWNSHIP 13, RANGE 12, OF THE CONGRESS LANDS EAST OF THE SCIOTO RIVER, WAYNE TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

BEGINNING AT THE SOUTHWEST CORNER OF THE NORTHWEST QUARTER OF SECTION 6, SAID CORNER BEING IN TOWNSHIP ROAD 193 (MILLER'S LANE); THENCE NORTH 00 DEGREES 00 MINUTES 00 SECONDS EAST 145.72 FEET ALONG THE WEST LINE OF THE SAID NORTHWEST QUARTER TO A POINT IN THE SAID ROAD; THENCE SOUTH 89 DEGREES 52 MINUTES 45 SECONDS EAST 191.99 FEET TO A POINT MARKED BY AN IRON PIN SET, PASSING A POINT MARKED BY AN IRON PIN SET AT 15.59 FEET; THENCE SOUTH 74 DEGREES 03 MINUTES 50 SECONDS EAST 99.28 FEET TO A POINT MARKED BY AN IRON PIN SET; THENCE SOUTH 38 DEGREES 21 MINUTES 37 SECONDS EAST 119.98 FEET TO A POINT MARKED BY AN IRON PIN SET; THENCE SOUTH 16 DEGREES 19 MINUTES 37 SECONDS WEST 49.61 FEET TO A POINT MARKED BY AN IRON PIN SET, SAID POINT BEING ON THE SOUTH LINE OF THE SAID NORTHWEST QUARTER OF SECTION 6; THENCE NORTH 86 DEGREES 06 MINUTES 49 SECONDS WEST 348.77 FEET ALONG THE SAID SOUTH LINE, (SAID LINE ALSO BEING THE NORTH LINE OF A TRACT CONVEYED TO W. AND H. MAXWELL BY DEED RECORDED IN DEED BOOK VOLUME 549 PAGE 633 OF THE MUSKINGUM COUNTY DEED RECORDS) TO THE PLACE OF BEGINNING, PASSING A POINT MARKED BY AN IRON PIN SET AT 334.65 FEET.

CONTAINING 1.146 MORE OR LESS ACRES, SUBJECT TO ALL LEGAL ROAD RIGHT-OF-WAY OF TOWNSHIP ROAD 193 AND ALL APPLICABLE EASEMENTS.

ALL IRON PINS SET ARE 5/8 INCH X 30 INCH REBAR WITH PLASTIC IDENTIFICATION CAPS.






