BEING A PART OF THE NORTHEAST QUARTER OF SECTION 7, TOWNSHIP 13, RANGE 12, OF THE CONGRESS LANDS EAST OF THE SCIOTO RIVER, WAYNE TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

COMMENCING AT AN EXISTING STONE AT THE SOUTHEAST CORNER OF THE SAID NORTHEAST QUARTER;

THENCE NORTH 00 DEGREES 13 MINUTES 45 SECONDS EAST 2268.20 FEET, ALONG THE EAST LINE OF THE SAID NORTHEAST QUARTER, TO AN EXISTING IRON PIN (3/8 INCH I.D. PIPE) AT THE NORTHEAST CORNER OF A TRACT CONVEYED TO S. MOYER BY DEED RECORDED IN VOLUME 1132, PAGE 614 OF THE MUSKINGUM COUNTY DEED RECORDS;

THENCE WITH THE NORTH LINE OF SAID MOYER TRACT SOUTH 87 DEGREES 14 MINUTES 47 SECONDS WEST 545.25 FEET TO A POINT;

THENCE WITH THE WEST LINE OF SAID MOYER TRACT SOUTH 11 DEGREES 35 MINUTES 12 SECONDS EAST 719.42 FEET TO A POINT IN THE CENTER OF TOWNSHIP ROAD 389 (THREE TOWERS ROAD), PASSING EXISTING IRON PINS (3/4 INCH I.D. PIPE) AT 0.32 FEET AND 699.42 FEET AND PASSING EXISTING IRON PINS (5/8 INCH REBAR) AT 202.94 FEET AND 434.72 FEET;

THENCE LEAVING THE SAID MOYER TRACT AND WITH THE CENTER OF SAID ROAD THE NEXT THREE COURSES AND DISTANCES:

- 1) SOUTH 60 DEGREES 31 MINUTES 20 SECONDS WEST 119.20 FEET TO A POINT;
- 2) SOUTH 57 DEGREES 23 MINUTES 58 SECONDS WEST 198.42 FEET TO A POINT;
- 3) SOUTH 61 DEGREES 51 MINUTES 55 SECONDS WEST 5.27 FEET TO A POINT, SAID POINT BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED;

THENCE CONTINUING WITH THE CENTER OF SAID ROAD THE NEXT TWO COURSES AND DISTANCES:

- 1) SOUTH 61 DEGREES 51 MINUTES 55 SECONDS WEST 88.98 FEET TO A POINT;
- 2) SOUTH 70 DEGREES 51 MINUTES 12 SECONDS WEST 11.78 FEET TO A POINT;

THENCE LEAVING THE SAID ROAD AND TRAVERSING INTO A TRACT CONVEYED TO R. & T. KOPCHAK (DEED VOLUME 1514, PAGE 80), NORTH 37 DEGREES 35 MINUTES 35 SECONDS WEST 236.69 FEET TO AN IRON PIN SET, PASSING AN IRON PIN SET AT 25.68 FEET;

THENCE NORTH 64 DEGREES 40 MINUTES 20 SECONDS EAST 100.00 FEET TO AN IRON PIN SET;

THENCE SOUTH 37 DEGREES 53 MINUTES 32 SECONDS EAST, PASSING AN IRON PIN SET AT 186.07 FEET A TOTAL DISTANCE OF 233.80 FEET TO THE PLACE OF BEGINNING.

CONTAINING 0.533 MORE OR LESS ACRES, SUBJECT TO ALL LEGAL ROAD RIGHT OF WAYS OF TOWNSHIP ROAD 389 (THREE TOWERS ROAD) AND ALL OTHER APPLICABLE EASEMENTS.

ALL IRON PINS SET ARE 5/8 INCH X 30 INCH REBAR WITH PLASTIC IDENTIFICATION CAPS (BIEDENBACH PS6923-PS7923).

BEARINGS ARE BASED ON THE EAST LINE (N.24°17'00"W.) OF A TRACT CONVEYED TO LARRY McCUTCHEON (DEED VOLUME 726, PAGE 248).
