BEING A PART OF LOT 4 OF GEORGE W. GIBBONS SUBDIVISION (RECORDED IN REPLAT BOOK 1, PAGE 124 OF THE MUSKINGUM COUNTY PLAT RECORDS), WHICH WAS CONVEYED TO GUY H. BLACKSTONE BY DEED FROM MINNIE A. AND FRED C. WERNER AS RECORDED IN VOLUME 207, PAGE 190 OF THE MUSKINGUM COUNTY DEED RECORDS; SITUATED IN THE NORTHEAST QUARTER OF SECTION 7, TOWNSHIP 12, RANGE 13, OF THE CONGRESS LANDS EAST OF THE SCIOTO RIVER, WAYNE TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

COMMENCING AT THE NORTHEAST CORNER OF SECTION 7; THENCE NORTH 84 DEGREES 21 MINUTES 24 SECONDS WEST 1233.38 FEET (BY DEED) ALONG THE NORTH LINE OF SAID SECTION TO A POINT; THENCE LEAVING THE SAID SECTION LINE, SOUTH 05 DEGREES 38 MINUTES 36 SECONDS WEST 168.50 FEET (BY DEED) ALONG THE WEST LINE OF A TRACT CONVEYED TO R. AND L. STROUSE AS RECORDED IN DEED VOLUME 525, PAGE 861 OF THE SAID COUNTY RECORDS TO A POINT; THENCE LEAVING THE SAID STROUSE TRACT, SOUTH 18 DEGREES 10 MINUTES 24 SECONDS WEST 379.00 FEET (BY DEED) ALONG THE WEST LINE OF A TRACT CONVEYED TO S. AND B. BUTLER AS RECORDED IN DEED VOLUME 640, PAGE 152 OF THE SAID COUNTY RECORDS TO AN EXISTING IRON PIN (3/4 INCH ID PIPE) AT THE NORTHWEST CORNER OF A TRACT CONVEYED TO M. AND E. SATTERFIELD AS RECORDED IN DEED VOLUME 874, PAGE 120 OF THE SAID COUNTY RECORDS; THENCE CONTINUING SOUTH 18 DEGREES 10 MINUTES 24 SECONDS WEST 99.99 FEET ALONG THE WEST LINE OF THE SAID SATTERFIELD TRACT TO AN IRON PIN SET AT THE NORTHWEST CORNER OF A TRACT CONVEYED TO C. KRONENBITTER BY DEED RECORDED IN VOLUME 350, PAGE 483 OF THE SAID COUNTY RECORDS; SAID IRON PIN BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED; THENCE WITH THE OCCUPIED LINE NORTH 72 DEGREES 07 MINUTES 54 SECONDS EAST, PASSING IRON PINS SET AT 241.08 FEET, 390.58 FEET, AND 523.28 FEET, A TOTAL DISTANCE OF 745.54 FEET TO AN IRON PIN SET AT THE SOUTHEAST CORNER OF SAID KRONENBITTER TRACT; THENCE WITH THE SOUTH LINE OF THE SAID KRONENBITTER TRACT, SOUTH 67 DEGREES 44 MINUTES 24 SECONDS WEST 791.99 FEET TO A POINT; THENCE WITH THE WEST LINE OF THE SAID TRACT NORTH 18 DEGREES 10 MINUTES 24 SECONDS EAST 75.00 FEET TO THE PLACE OF BEGINNING.

CONTAINING 0.519 MORE OR LESS ACRES, SUBJECT TO ALL APPLICABLE EASEMENTS.

ALL IRON PINS SET ARE 5/8 INCH X 30 INCH REBAR WITH PLASTIC IDENTIFICATION CAPS.
