SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM, TOWNSHIP OF WAYNE, AND BEING PART OF THE NORTHWEST QUARTER OF SECTION 8, TOWNSHIP 12, RANGE 13, AND BEING PART OF THOSE LANDS INTENDED TO BE DESCRIBED IN DEED VOLUME 489, PAGE 636; BEING FURTHER BOUNDED AND DESCRIBED AS FOLLOWS:

COMMENCING AT AN IRON PIN FOUND AT THE SOUTHWEST CORNER OF THE NORTHWEST QUARTER OF SECTION 8, THENCE, NORTH 51 DEGREES - 28 MINUTES - 24 SECONDS EAST, 911.54 FEET TO AN IRON PIN FOUND; THENCE, NORTH 43 DEGREES - 26 MINUTES - 00 SECONDS WEST, 166.15 FEET TO AN IRON PIN FOUND; THENCE, NORTH 38 DEGREES - 16 MINUTES - 40 SECONDS EAST, 72.26 FEET TO AN IRON PIN SET, AND THE TRUE POINT OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED; THENCE, CONTINUING NORTH 38 DEGREES - 16 MINUTES - 40 SECONDS EAST, 187.03 FEET TO A POINT IN THE CENTER OF WAYNE RIDGE ROAD (COUNTY ROAD 73), PASSING AN IRON PIN FOUND AT 167.03 FEET; THENCE, ALONG SAID ROAD, THE FOLLOWING FOUR (4) COURSES AND DISTANCES:

- 1) SOUTH 63 DEGREES - 52 MINUTES - 35 SECONDS EAST, 34.62 FEET TO A POINT;
- 2) SOUTH 57 DEGREES - 44 MINUTES - 10 SECONDS EAST, 38.26 FEET TO A POINT;
- 3) SOUTH 50 DEGREES - 14 MINUTES - 04 SECONDS EAST, 51.83 FEET TO A POINT;
- 4) SOUTH 45 DEGREES - 18 MINUTES - 50 SECONDS EAST, 84.06 FEET TO A POINT;



