

Situated in the State of Ohio, County of Muskingum, Township of Wayne.

Being a part of the Northeast Quarter of Section 9, Township 12, Range 13 bounded and described as follows:

Commencing at an iron pin found at the Southeast Corner of the Northeast Quarter of Section 9; thence along the Quarter Section Line north 85 degrees 07 minutes 27 seconds west 525.0 feet to an iron pin and the true place of beginning of the premises herein intended to be described; thence north 85 degrees 07 minutes 27 seconds west 595.80 feet to an iron pin; thence north 3 degrees 53 minutes 36 seconds east 267.83 feet to an iron pin; thence north 19 degrees 57 minutes 05 seconds west 178.0 feet to an iron pin; thence north 12 degrees 37 minutes 05 seconds west 460.25 feet to an iron pin found; thence north 4 degrees 30 minutes 05 seconds west 235.47 feet to a point in the center of State Route #146; thence along said centerline on a curve to the right having a radius of 1432.39 feet an arc length of 284.79 feet (the chord of which bears south 75 degrees 04 minutes 45 seconds east 284.32 feet) to a point; thence continuing along said centerline south 69 degrees 23 minutes east 476.01 feet to a point; thence leaving said centerline south 13 degrees 33 minutes west 312.40 feet to an iron pin; thence south 71 degrees 07 minutes 48 seconds east 246.72 feet to an iron pin; thence south 12 degrees 57 minutes 14 seconds west 558.97 feet to the true place of beginning, containing fifteen and sixty-six hundredths (15.66) acres more or less.



