AUDITORS PARCEL
73-27-01-28-000 (1.90 Acres)

Situated in the Northeast Quarter of section 10, T-12, R-13, of the Congress lands East of the Scioto River, Wayne Township, Muskingum County, Ohio. Being the lands of Faye Johnson conveyed in Deed Book 1152 page 21 of the Muskingum county deed records and being described as follows;

Commencing at the Northwest corner of the Northeast Quarter of Section 10; Thence, S.02°20'21"W. a distance of 1647.12 feet along the west line of said quarter section to a found iron pin on the Southwest corner of a 25.72 acre parcel, now or formerly, owned by D. Mahon (1104/271); Thence, S.84°20'57"E. a distance of 144.17 feet along said Mahon lands to a found iron pin, BEING THE POINT OF BEGINNING;

Thence, S.84°20'57"E. a distance of 170.46 feet along said Mahon lands to a found iron pin on the Northwest corner of the lands, now or formerly, owned by T. McClure, et al (1897/907);

Thence, S.10°25'35"W. a distance of 489.08 feet along said McClure lands to a found iron pin on the North line of State Route 146 (Chandlersville Road);

Thence, N.85°22'59"W. a distance of 169.07 feet along said road way to a found iron pin on the Southeast corner of the lands, now or formerly, owned by R. Lashley (894/164);

Thence, N.10°13'58"E. a distance of 492.00 feet along said Lashley lands to the point of beginning.

The above described parcel contains 1.90 acres, more or less, subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.



SCALE 1" = 120'




