

DESCRIPTION OF SURVEY FOR LURA K WINTERS ESTATE JOB#2744-2

Situated in the State of Ohio, County of Muskingum, Township of Wayne:

Being part of the Southwest Quarter of Section 10, Township 12, Range 13, of the Congress Lands East of the Scioto River, further **being part of** the Lura K Winters property recorded in **Official Record Volume 2838, Page 813**, further **being all of** Muskingum County Auditor's Parcel Numbers **73-27-02-69-000, and 73-27-02-00-800**, and more particularly described as follows;

Beginning at a stone (found) at the common corner for Section 9, 10, 11, and 12 of said Township and Range;

- #1- **THENCE North 01 degrees 58 minutes 31 seconds East 2330.59 feet** along the common line for Sections 9 and 10 and through said Winters property to an unmarked point on the Denise E Winters Trustee property recorded in Official Record Volume 2871, Page 843;
- #2- **THENCE South 60 degrees 14 minutes 29 seconds East 305.73 feet** into Section 10 and along a common line for said Winters properties to an iron pin (located by metal reading at base of tree) being a corner of the Randall D Tom II and Tiffany N Tom property recorded in Official Record Volume 3086, Page 322, passing an iron pin (found capped 6885) at 10.59 feet;
- #3- **THENCE South 16 degrees 16 minutes 59 seconds East 124.26 feet** along said Lura Winters and Tom properties to an unmarked point in an unnamed tributary of Boggs Creek, passing an iron pin (found capped 6885) at 115.40 feet;
- #4- **THENCE South 58 degrees 57 minutes 53 seconds East 420.10 feet** continuing along said properties to an iron pin (found capped 6885), passing an iron pin (found capped) at 330.12 feet;
- #5- **THENCE South 02 degrees 02 minutes 07 seconds West 263.99 feet** continuing along said properties to an iron pin (found capped 6885);
- #6- **THENCE South 58 degrees 57 minutes 53 seconds East 1461.20 feet** continuing along said properties to an iron pin (found capped 6885) on the common line for the Southwest and Southeast Quarters of Section 10;
- #7- **THENCE South 02 degrees 34 minutes 56 seconds West 917.32 feet** along said Quarter Section line and common line for said Lura Winters property and for the Kim K Kerns property recorded in Official Record Volume 2644, Page 762 to an iron pin (set) on the common line for Sections 10 and 11 replacing a metal fence post previously located now disturbed;
- #8- **THENCE North 87 degrees 17 minutes 19 seconds West 1944.05 feet** along the said Section line and common line for said Lura Winters property and for the Charles J Myers III Trustee property recorded in Deed Book Volume 1126, Page 115 and Official Record Volume 2644, Page 525 to the place of beginning, **containing 68.91 acres.**
