DESCRIPTION OF PARCEL # 73 - 27 - 02 - 47 WHICH WAS CONVEYED TO AMERICAN HOUSING TRUST II IN VOLUME 1012, PAGE 315 OF MUSKINGUM RECORDS.

Situate in the State of Ohio, County of Muskingum , Township of Wayne, and being a part of the Northwest Quarter of Section # 10 , Township 12 North , Range 13 West , in the Congress Lands East of the Scioto River and being all of parcel # 73 - 27 - 02 - 47 as conveyed to American Housing Trust II in Deed Volume 1012, Page 315 , of the Muskingum County Deed Records, and being more particularly bounded and described as follows:

Beginning for reference at a point at the Southeast corner of the Northwest Quarter of Section # 10, Township 12 North , Range 13 West , in the Congress Lands East of the Scioto River , thence North 02 degrees 38 minutes 09 seconds East 646.99 feet to a point in the South Right of Way line of State Route # 146 (Chandlersville Road) ; thence along the south Right of Way line , North 86 degrees 53 minutes 00 seconds West 755.86 feet to an iron pin set and the True Place of Beginning ; thence along the west line of W. & J. Sprague property (Vol. 1150 Pg. 824) , South 08 degrees 11 minutes 59 seconds West 393.91 feet to an iron pin found ; thence along the line of J. Tom property (Vol. 1092 Pg. 217) , North 63 degrees 24 minutes 13 seconds West 70.28 feet to an iron pin found ; thence along the line of C.F. & W.L. Echelberry property (Vol. 544 Pg. 543) , North 07 degrees 43 minutes 25 seconds East 365.54 feet to an iron pin set ; thence along the Right of Way line of State Route # 146 (Chandlersville Road) South 86 degrees 53 minutes 00 seconds East 70.00 feet to an iron pin set at the True Place of Beginning.

Containing 0.594 Acres, more or less, subject to all easements , restrictions , or right of ways , either written or implied. All iron pins set are 30 inch long by 5/8 inch diameter rebar with a yellow cap labeled "BINCKLEY S-7879".

Bearings contained herein are assumed from a previous survey by W.J. Biedenbach dated 7 - 16 - 1981 of the south Right of Way line of State Route # 146 (Chandlersville Road) as being North 86 degrees 53 minutes 00 seconds West and are for angular measurement only.



