Situated in the Township of Wayne, County of Muskingum, State of Ohio, and being a part of the Southwest Quarter of Section 14, Township 12N, Range 13W, and being more particularly described as follows;

Being a Re-Survey of a 0.22 acre parcel conveyed to Phillip S. MacLaine, Jr. & Patricia A. MacLaine, as recorded in Volume 487, Page 116, in the Muskingum County Deed Records, and being all of Auditor's Parcel No.73-73-36-03-13-000, and being further described as follows;

Commencing for reference at the Northwest corner of the Southwest Quarter of Section 14;

Thence, S 83°40'00" E 562.24 feet to the West line of an ingress/egress easement, as recorded in Volume 487, Page 28, and passing over 1" o.d. iron pins found at 258.40 feet and 425.44 feet;

Thence, S 02°58'00" E 196.38 feet with the West line of said ingress/egress easement to a 1" o.d. iron pin found marking the Southeast corner of a 0.31 acre parcel conveyed to Phillip S. MacLaine, Jr., & Patricia A. MacLaine, as recorded in Volume 487, page 118, and being the PRINCIPLE PLACE OF BEGINNING of the 0.217 acre parcel herein to be described;

Thence, S 02°58'06" E 70.08 feet continuing with the West line of said ingress/egress easement, to a 1" o.d. from pin found on the North line of a 1.821 acre parcel conveyed to Vickie D. MacLaine, as recorded in Volume 842, Page 28;

Thence, S 87°10'15" W 135.06 feet with the North line of said 1.21 Acre parcel, to a 1" o.d. from pin found on the East line of a 0.538 Acre parcel conveyed to Vickie D. MacLaine, as recorded in Volume 1660, Page 573;

Thence, N 42°41'40" W 70.11 feet with the East line of said 4.538 acre parcel and extending along the East line of a parcel conveyed to Carol Boyer, as recorded in Volume 1041, Page 103, to a 1" o d. from pin found marking the Southwest corner of said parcel conveyed to MacLaine, and passing over a 5/8" o.d. fron pin found at 20.10 feet;

Thence, N 87°11'04" E 134.73 feet with the South line of said 0.31 acre parcel conveyed to MacLaine, to the PRINCIPLE. PLACE OF BEGINNING, and containing 0.217 acres, more or less, and subject to all legal easements, right of ways, restrictions, and zoning ordinances of record.

Bearings of the above description are based on the West line of an ingress/egress easement, as recorded in Volume 842, Page 28, in the Muskingum County Deed Records, as being S 02°58'00" E, and is an assumed Meridian used to denote angles only.

All iron pins set are 5/8" o.d. iron pins 30" long with red caps labeled "S.A. ENGLAND #S-7452",




